Questions from Members of the Council under Council Procedure Rules 12 and 5(1)(i) and 5 (2)(m)

(1) Question by Councillor A Pinnock to the Cabinet Member for Place (Councillor McBride)

"The Cabinet Member will not have failed to notice POL site developments rejected at committee level now being overturned on appeal because Kirklees does not have a Core Strategy. The situation is grave. What have you done since last Council Meeting to get a revised LDF ready and submitted so we can halt the unchecked development of our green spaces?"

"The LDF Inspector first wrote back to the Council in April this year airing his concerns about the core strategy. Six months have now gone by. Given the importance of the Core Strategy in protecting green fields, I put it to you that it would have been prudent for Cabinet to get work started quietly behind the scenes on a revised LDF Strategy to get us ahead of the game in event of withdrawal. Why didn't you do that?"

"At the last council meeting on the 23rd of October I asked whether the Council intends to spend capital to repair Tolson Museum. The response I got was "see the Capital plan". Although I didn't need to look again, the Cabinet Member will be pleased to hear that I took their advice and checked what the plan said about Tolson Museum. What it told me was that when the plan was agreed there was no money allocated to repair and improve Huddersfield's only museum despite it desperately needing investment. Can I ask the Cabinet Member whether - now that attention has been drawn to the shear scale of investment required at Tolson - whether their future priorities for Capital spending will include or exclude Tolson Museum?"
